## **Client Setup**

In FMS industry, the total process of Invoicing and payments depends on the contract agreement, and this is not unique for every client. cuteVista provides a facility to setup the client wise billing process, payment process etc following norms statutory principles as per the contract agreement made with the client. It also gives the provision to maintain the wages minimum pattern which varies from state to state.

#### **Human Resource**

In FMS Industry, Attrition rate of employee is more, it may be because of the employee abscentism or indiscipline nature of an employee which leads to termination. It is very important for an organization to maintain the database of all the employees along with the joining and leaving details so that the person terminated at one place should not join at other branch of the same organization. Especially for security industry the police verification is compulsory in many states and it is going to through-out India. cuteVista maintains the Master data of Employee with present along the deployment status of an employee so that the information about any employee (present / terminated resigned) made available immediately. cuteVista automates the full Human Resource operations such as Pre-recruitment / recruitment process such as issuing of the identity cards and deploying at Complete automation of filling

of forms for applying security clearance, PF and ESI enrollment etc. In case of mass recruitment, Bulk uploading and updating the employee data is available.

#### Statutory

Any change in financial policy by the Govt of India will be given with effective date. If it falls in the course of the month, then it becomes difficult for the organization to make the bills by following two conditions in the same month. cuteVista simplifies this issue by providing administrator rights to change the values from front end. The settings can be applied as per the state rules or central rules according to the requirement along with the effective date. The statutory norms include PF, ESI, Professional Tax, TDS, Service Tax, Sales Tax, and VAT.

#### Personnel

This module takes care of the Claims / Deductions and leave management. Deductions are loans, salary advances, uniform deductions etc. Claims are like mobile allowances, travel claims, food allowances on OT etc. cuteVista automates complete the process without human intervention after initial settings.

# **Payroll**

As the contract varies from client to client, The salary sheets & pay slips need to be generated as per the client requirement. cuteVista generates the dynamic pay sheet and pay slip as per the actual duties performed by an employee. Complete

customization of fields for pay sheet and pay slip can be defined by user. There a provision to formulate the Fields like Gross, Tot Ded, Net pay, PF, ESI from front end. All deductions and Claims will be calculated accurately as per the settings. cuteVista calculates all the taxes PF, ESI, PT and TDS as per the statutory norms accurately. different combinations for payments are available. There is a provision for payment calculation options such as full month, 26 days, excluding weekly off etc. Consolidated Pay slip to an employee irrespective of the number of units he performed the duties. Exporting of paysheet to Excel / PDF. A standardized Bank payment format in excel. Arrears calculation with PF / ESI deductions. Stop payment option is available.

#### Invoicing

In Facility Industry, Manpower plays vital role for billing. cuteVista understands requirement of Facility Industry and generates the dynamic invoice linking by with attendance for security industry where as for House keeping industry both attendance, material & machine. Auto generated E-Mail facility to client to send the generated invoice & annexure as an attachments. There is a provision for payment calculation option such as full month, 26 days, excluding weekly off etc. Accurate calculation of Service Tax, Sales Tax and VAT, Provision to an administrator to change values in case of any change in VAT % or ST % rates by Govt. along with the effective date. Generation of combined

invoices for set of units based on region / state / country. Maintenance of receipt payments, credit / debit notes and sales ledger.
